

PARKING

Parking continues to be an issue in front of the Community Room of Pequot Village. Due to the limited parking; parking spaces in front parking lot of the community room at Pequot Village are for handicap residents (or residents who have difficulty walking) of buildings 31 and 35 Village Lane and Visitors of the office ONLY. Exception is on Wednesday for Bingo. All others should be using the parking area up top in front of building 31. Vehicles could be subject to towing.
