AREAS ONLY. RSC WILL HAVE YOUR RENT FOR 2022. IF

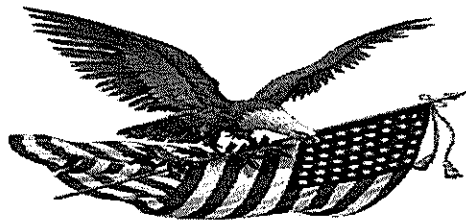
