RENTERS' REBATE



GROUNDS

NO SMOKING!

GHA continues to receive complaints from residents and staff of residents smoking in their units or on the property. This is a violation of GHA's no smoking policy as well as State Law regarding no smoking in Public Housing. Violators could be charged for damages and could lead to eviction.

Questions came up about residents being told they can smoke on the property. There is "NO Smoking Allowed" on the property or in the units. This includes smoking of any kind or substance.

PARKING

Please be sure to park in designated parking only. Visitor parking is reserved for visitors. Please use your assigned or tenant parking to park your vehicles.

LANDSCAPING

GHA has begun landscaping work this month. Lawns will be mowed on Tuesdays and Wednesdays (weather permitting). Other trimming and clean up can occur anytime during the week.
